CASA-NYC is a New York City-based nonprofit organization serving children and youth in foster care and at a high risk of foster care placement. Family court judges in all five boroughs assign CASA-NYC to a case when they are concerned that a child is at risk of “falling through the cracks” of the child welfare system. With the help of approximately 275 volunteers from across New York City, we serve 1,000 of the 10,000 young people in the foster care system each year. *Supper Club* raises critical funding to sustain and extend our crucial role in assisting the overburdened family court system in meeting the needs of our city’s most vulnerable children.
